Energy Transition and Low Carbon Energy

The landscape of the North American low carbon energy market has changed post COVID pandemic with the introduction of the Inflation Reduction Act (IRA) and incentives announced by the Government of Canada and Alberta. This has kicked off an unprecedented growth in low carbon hydrogen, CCS and CCUS projects. Enerqui's has been involved in investment evaluation and planning of hydrogen, wind, CCS, CCUS, baseload geothermal energy, underground energy storage (hydrogen, natural gas, air), energy security and several other energy projects. Some of the projects that we have worked on are:

- Integrated cross functional team to evaluate the feasibility and commerciality of a multifaceted wind to hydrogen investment in eastern Canada and export to international markets.
- Developed relationships with strategic partners to secure funding for the first geothermal to hydrogen investment in Canada.
- Provided clear direction to achieve Net Zero targets economically by identifying key commercial and financial drivers, evaluating investments in CCS, hydrogen or renewables for a client's portfolio of industrial plants.
- Led efforts to secure strategic investors to develop 50 MW \$140 mil. geothermal plants in LATAM. Developed financial models with commercial incentives allowing attractive returns.
- Formulated growth strategy for underground energy storage; repositioned and marketed as baseload energy storage for hydrogen and energy security post geopolitical events in 2022.

Digitalization and Data Analytics utilizing Big Data

- Created central platform by consolidating data from various social media, webstore sources
 and websites for all analytics requirements. All reporting, dashboards and KPIs generated in
 one place providing detailed insights of marketing, channel effectiveness, budgeting and ROI,
 to facilitate investment decisions.
